





Whereas **Samskruti College of Pharmacy** has agreed to collect and give away the dry recyclable waste including any kind of Dry and Wet Waste generated in its college.


NOW THIS MOU WITNESSETH AS UNDER:




Roles and responsibilities of NEERU:


1. NEERU will collect dry recyclable waste and old records from college and bring to their facility without any spillage.
2. NEERU will organize sorting of the dry waste into different categories baling, and appropriate disposal of Wet Waste convert into bio meth nation process for using cooking fuel.
3. NEERU shall undertake necessary measures for dispatch of the sorted recyclables for recycling at its own cost.
4. E- waste will be recovered by NEERU authorized partnering company and safely dismantle / discard the waste.
5. NEERU will make payment to Samskruti College of Pharmacy directly into their accounts for the dry recyclable waste collected against the accurate weighment and the type or category of the dry waste. The payment shall be made on later than 15 days from the date of purchase of dry waste from the waste collector. NEERU on the request of Samskruti College of Pharmacy may give New A4 paper sheets, Notebooks and Stationary against the value of dry recyclable waste lifted.




Article-6:




