Vide reference cited certain special concessions are given to the handicapped students studying Engineering, Pharmacy, MBA & MCA courses. According to the G.O. the following concessions are to be given.

1. Exemption from payment of examination fee by deaf, dumb, hearing impaired, orthopedically handicapped and visually handicapped students of Eng, Pharmacy, MBA&MCA.
2. Reduction of pass marks, in each subject by 10% for deaf, dumb, hearing impaired, orthopedically handicapped and visually handicapped students of Eng, Pharmacy, and MBA&MCA.
3. Permission to use the services of a scribe and 30 minutes extra time to write the university examinations in case of orthopedically handicapped students of Engineering and Pharmacy.

Hence, you are requested to take steps for receiving information and requests from the eligible students and submitting the same to the University at the earliest.



I am to inform that Govt. of India enacted "Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995" in which it is stated that Person with disability means a person suffering from not less than forty percent of any disability as certified by a medical authority

Further vide letter No.11-1/CCD/2010/R1909 dated 12.05.2011 Deputy Chief Commissioner, Office of the Chief Commissioner for Persons with Disabilities, Ministry of Social Justice and Empowerment, New Delhi has requested the Secretary, UGC to circulate for considering to provide following concessions / facilities for students with disabilities in addition to 3% reservation of seats in all universities:

- i. Waiver of fee;
- ii. Electric Wheelchair at the mess and library;
- iii. Free accommodation, food, and transport.

Further I am to inform that the Government issued orders vide reference cited that the minimum percentage of disability shall be 40% of any kind of disability as certified by the medical authority to apply for facilities, concessions and benefits admissible under the schemes of Government or Non-Governmental organizations.
