The college has institutionalized the following policies for facilitating the Students with Disabilities:

- To provide personal and professional counseling, keeping in view their special needs.
- To encourage students with disabilities from rural background to pursue higher education, college has made few special provisions.
- Will not reject any admission on basis of being differently abled.
- Disseminate information regarding government or university orders dealing with fee concessions, examination procedures, reservation, policies, etc., pertaining to differently abled persons.
- Assess the educational needs of differently abled persons enrolled in the higher education institutes to determine the types of assistive devices to be procured.

Support System: Support system enables people with disabilities to move about safely and freely, and use the facilities within the built environment. The disabled friendly equipment is to provide an environment that supports the independent functioning of individuals so that they can participate without assistance, in everyday activities. To the maximum extent possible building is supported with railings for their accessibility. The ramp shall be wide enough that a wheelchair user can use it without any problem. A wheel chair is also provided by the institution.

Disabled friendly Washrooms: Separate washrooms with Western Waters Closet and grab bars are arranged in the ground floor and in the second floor. Toilets shall be wide enough for free movement of differently abled students.

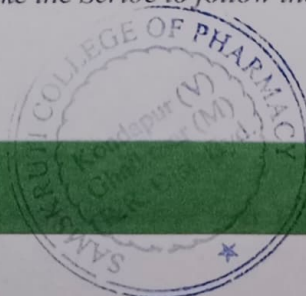

- 1) Medical Certificate issued by a Civil Surgeon working in a Government Hospital.
- 2) Photo of the student / candidate highlighting the inability to appear for the examination.
- 3) The Particulars of proposed scribe i.e., name, address, qualifications and present occupation. [The scribe should be of **intermediate** qualification with **arts subjects** only].
- 4) A letter from the scribe stating that he /she is willing to act as scribe.
- 5) A copy of the certificate of scribe's qualification along with recent photograph duly attested by the Principal.
- 6) A letter from the Principal stating that he/she personally verified and satisfied regarding qualification of the scribe as per norms and that he/she will provide a separate room and invigilator for all the examinations of the candidate.

In the case of students who are eligible for availing the services of scribes, the Principal shall authorize to appoint scribes according to the conditions specified by the JNTUH along with the following.

1. The scribe shall not be an employee of the college/centre where the examination is conducted.
2. The scribe shall not be a relative of the student who is appearing for the examination.
3. The educational qualifications of the scribe shall be less than those of the student.
4. A proforma with declaration in the format given institute shall be obtained from the scribe. The pro forma signed by the scribe shall be forwarded to the institute.

The Government of India has notified guidelines for evaluation of the disabilities and procedures to be adopted at Higher Educational Institutions. The institution as per the guidelines of the government and that of the affiliating university will ensure that the persons with disabilities are encouraged.

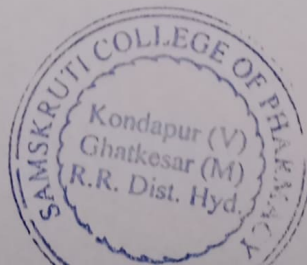

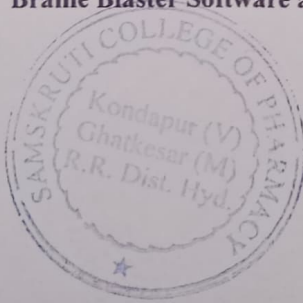
Well lighted and ventilated class room and Library in the college.

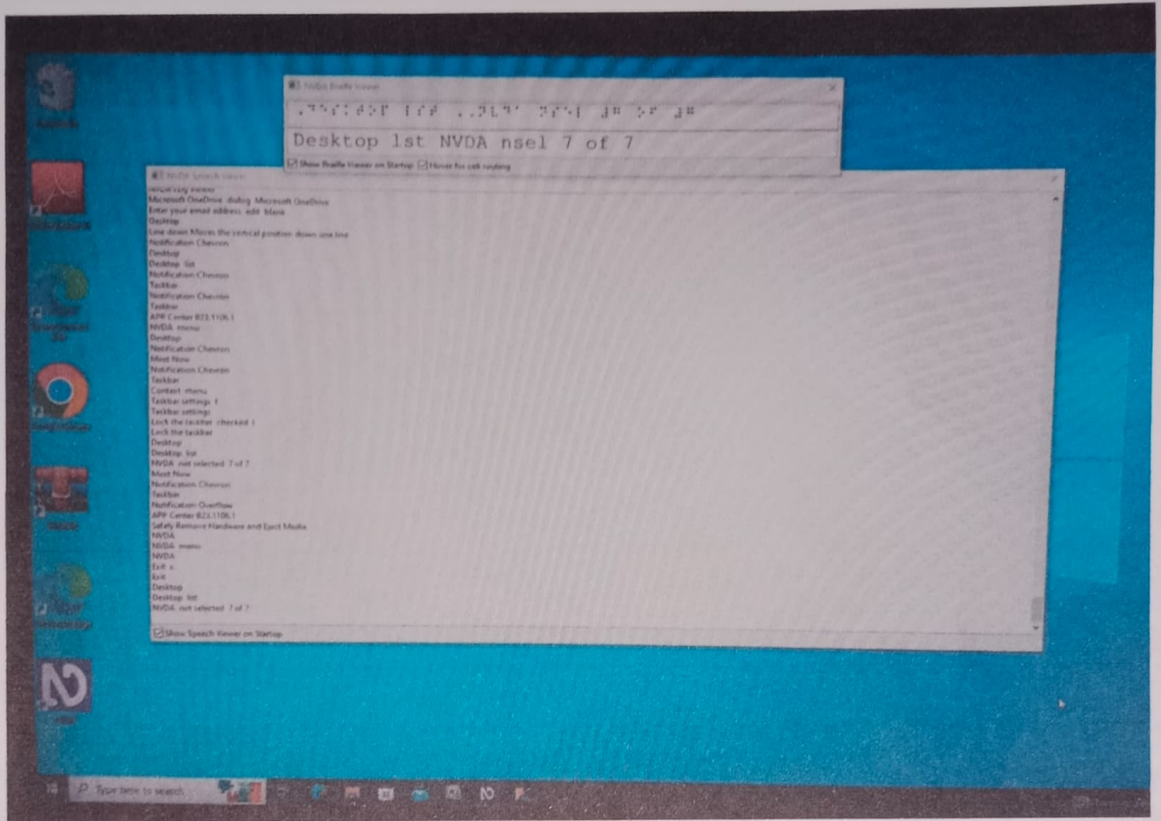


Braille Blaster Software available in the college.
