The institution should explore the possibilities of adopting eco-friendly culture and green buildings. The built environment of the institution should reflect institution's commitment towards ecology as far as possible.

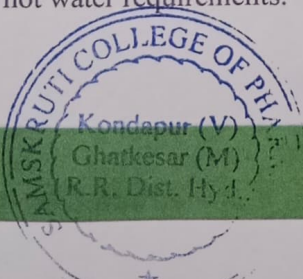
### **Some of the key areas that the Institution should concentrate adherence to the Green Policy guidelines as are given below:**




## GREEN POLICY CIRCULAR

## CIRCULAR-PAPERLESS OFFICE

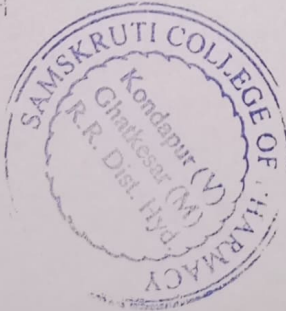
All the Staff members & students are hereby informed to make the office of the college a paperless one. In this regard the below said observations must be followed:
