In such an event, the notifying party shall promptly inform the other party in writing, providing full details of the situation. Both parties shall make reasonable efforts to find mutually satisfactory solutions to overcome the difficulties arising from these circumstances.
- **Arbitration:** Any disputes arising from this agreement shall be resolved through mutual consultations between both parties. In the event a settlement cannot be reached, the dispute(s) shall be subject to the provisions of the Arbitration & Conciliation Act, 1996. The arbitration proceedings shall take place in Hyderabad as the designated venue.

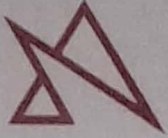




