WHEREAS KAMINENI HOSPITALS, which is offering health care is a well-established hospital with 356 beds capacity and is successfully running from its inception ie., September 1996 and thereby has completed 23 years. It is also having a Pharmacy Practice wing of 1500 sft.

AND WHEREAS SAMSKRUTI COLLEGE is offering courses in graduate and post graduate level of pharmacy having been running successfully for the last 14 years. It is also offering the Pharm D and Pharm D (Post Baccalaureate) courses integrated with pharmacy practice services since 2013.

AND WHEREAS for imparting pharmacy practice services, as per the regulations of Pharmacy Council of India, a minimum of 300 beds are required in the ratio of pharmacy students to beds as 1:10 which is the requirement of PARTY OF THE SECOND PART.

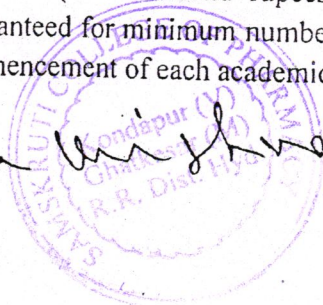
AND WHEREAS SAMSKRUTI COLLEGE, approached the KAMINENI HOSPITALS with a request to allow the students in the specified clinical departments for which PARTY OF THE FIRST PART agreed to provide the same.

AND WHEREAS after due deliberation & discussion and as per G.O.Ms.No.398, dated 15-11-2006 of Govt of Andhra Pradesh, KAMINENI HOSPITALS and SAMSKRUTI COLLEGE have agreed to be associated and engaged and as deemed it fit and expedient to reduce the same into writing and hence this Memorandum of Understanding (M.O.U.) on the following terms & conditions.

NOW, THEREFORE THIS MEMORANDUM OF UNDERSTANDING (MOU) WITNESSETH AND IS AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. It is agreed between the parties that, KAMINENI HOSPITALS shall permit the students of Pharm D and Pharm D (Post baccalaureate) of SAMSKRUTI COLLEGE to do their Pharmacy Practice and Clinical Pharmacy activities as per the syllabus prescribed by Pharmacy Council of India from the academic year 2013-14 onwards in the hospital.
2. It is agreed between the parties that, KAMINENI HOSPITALS shall allow the students of Pharm D and Pharm D (Post Baccalaureate) of SAMSKRUTI COLLEGE to utilize the facilities of KAMINENI HOSPITALS situated at L. B. Nagar, R. R. District for the purpose of Pharmacy Practice activities from the academic year 2013-14 onwards, admeasuring 1500 sft. within its hospital premises as per the regulations of Pharmacy Council of India, for the above said purpose.
3. It is hereby agreed that in consideration of KAMINENI HOSPITALS, providing facilities in Pharmacy Practice, SAMSKRUTI COLLEGE shall hereby unequivocally agrees and undertakes to pay an amount of Rs : 10,000/- (Ten thousand rupees only) per student/per annum to KAMINENI HOSPITALS as guaranteed for minimum number of students as stated in clause IV of this MOU, well before the commencement of each academic year with effect from 2013-14.

- Thirty each in II, III, IV, V, VI years

It is further agreed that the PARTY OF THE SECOND PART is alone responsible and liable for all statutory and regulatory compliances whatsoever in nature and with respect of courses offered and conducted and any research conducted at the premises of the KAMINENI HOSPITALS, along with all the required costs and any consequences (civil or criminal) thereof by the SAMSKRUTI COLLEGE.

That KAMINENI HOSPITALS shall be indemnified and shall in no way be held responsible or liable for any non-compliances and further penalties by the authorities and Regulators, whatsoever, due to any such regulatory non-compliance and any untoward incident that may take place during the research project's tenure.

8. **Tenure:**

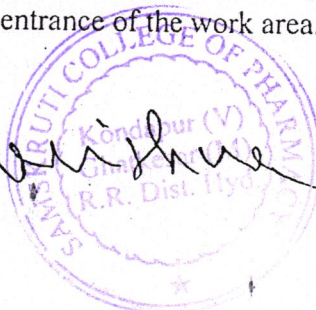
